Appendix

Improvement Districts Act

Improvement Districts No. 5 and No. 8 Boundary Adjustment Order

1. The boundaries of Improvement Districts No. 5 and No. 8 are altered in the following manner.
 - (a) That there be added to Improvement District No. 5, in the Province of Alberta, and thereupon removed from Improvement District No. 8, all territory that is at present within the jurisdiction of Improvement District No. 8, and that is bounded and contained within the boundary described in Schedule "A", Description of Territory Added to Improvement District No. 5.
2. (a) That any taxes owing to Improvement District No. 8 as at December 31, 1987, in respect of land and properties added to Improvement District No. 5 shall transfer to and become payable to Improvement District No. 5 together with any lawful penalties and costs levied thereon in respect of any such taxes; however, upon Improvement District No. 5 collecting any or all such taxes, penalties or costs, such collection shall forthwith be paid by Improvement District No. 5 to Improvement District No. 8.
3. (a) That the assessors for Improvement District No. 5 and Improvement District No. 8 shall, for 1988 taxation purposes, reassess the added lands and assessable improvements thereon as if they were located within the respective improvement districts on December 31, 1987, so that the assessment thereof shall be fair and equitable with other lands and assessable improvements in the improvement district and the provisions of the Municipal Taxation Act regarding assessment shall mutatis mutandis apply to each assessment.
 - (b) The added lands and assessable improvements thereon shall be taxable by the improvement district to which they are annexed commencing January 1, 1988.
4. That the effective date of this Order is the Thirty-first (31st) day of December, A.D., 1987.

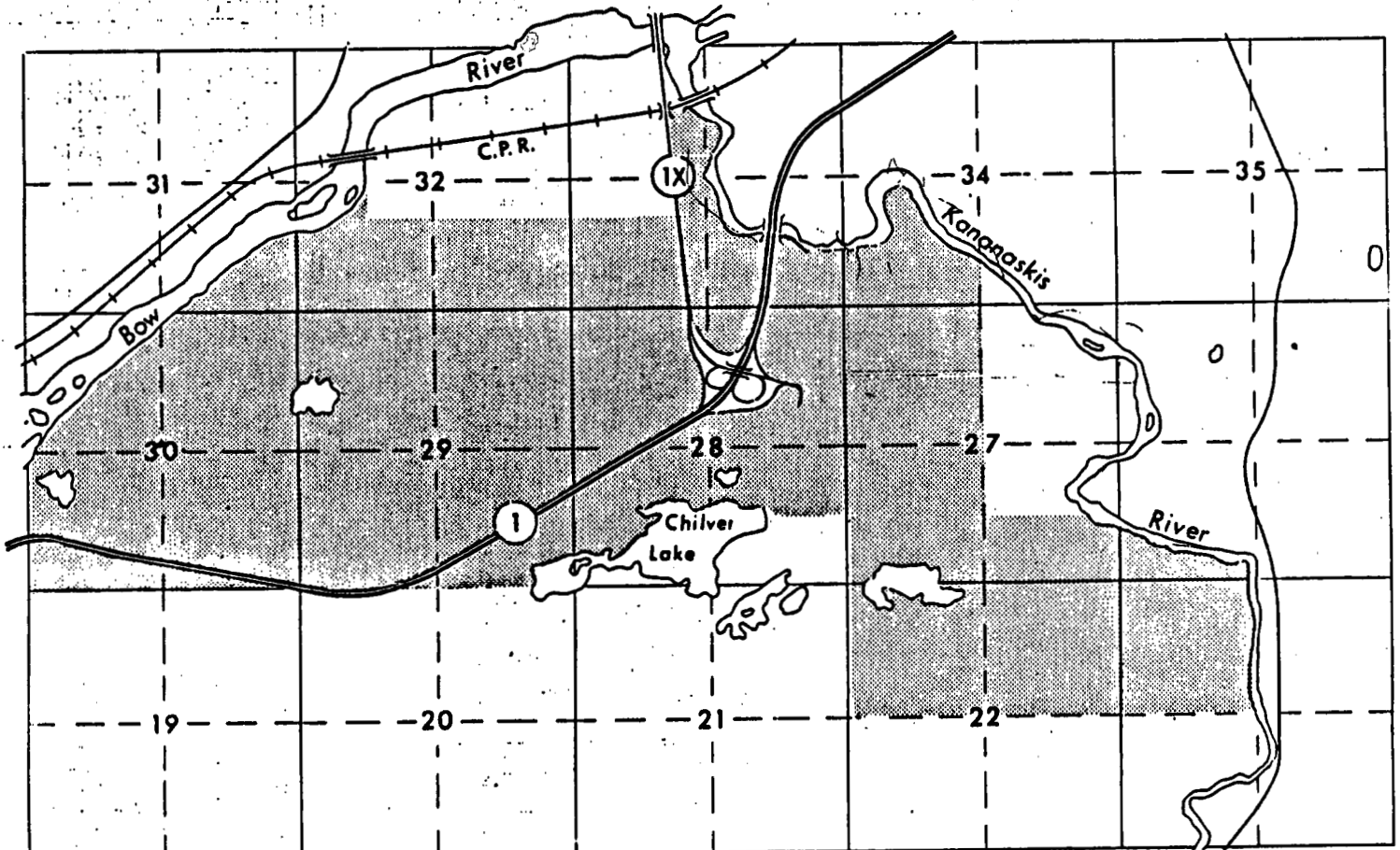

SCHEDULE A

All that parcel or tract of land, situated, lying and being in the Province of Alberta, Canada; and being of Improvement District No. 8 and more particularly described as follows:

All those portions of the North Half of Section 27 being Legal subdivision 13, 14, 15 and 16 in Section Twenty-Seven (27).

All those portions of the South Half of Section 34 lying south of the Kananaskis River
