## TERMS OF PAYMENT

Remittance should be made payable to the **KANANASKIS IMPROVEMENT DISTRICT** by accepted bank cheque, bank draft, money order, postal note, treasury voucher, treasury cheque, or in currency. Cheques and bank drafts must be **payable at par**. Currency should be sent by registered mail. The postmark will determine date of payment.

**AMOUNT DUE** All taxes are due and payable as stated on the front of this notice. Failure to receive a tax notice is not a reason for non-payment of taxes by the due date.

**PENALTIES** All taxes remaining unpaid after the due date will have a penalty imposed at the rate stated on the front of this notice effective the date after due date. A penalty will be added each year following, as long as the taxes remain unpaid. All penalties are subject to change pursuant to section 344 and 345 of the Municipal Government Act.

**APPEALS** Your taxes must be paid by the due date even though you may have appealed your assessment. If an appeal is successful, any overpayment will be refunded. If you wish to appeal your assessment or any assessment you must lodge your complaint in writing, within 30 days of the date of this notice, with the Assessment Clerk, Kananaskis Improvement District.
